WHEREAS, the Monroe County Circuit Court has a need to upgrade, operate and maintain their current copier including hardware/software system within the respective offices, and

WHEREAS, the current copier is not sufficiently meeting the needs of the function of the department in concern, and

WHEREAS, the proceeds for a multi year lease agreement are currently budgeted within the Monroe County General Fund Budget as deemed necessary in order to expedite the resolution of this matter, and

WHEREAS, the projected cost of this copier hardware/software system is such that the payments need to be spread over more than one budget year, and the Monroe County Director of Finance does not have the authority to enter into purchase contracts for this period of time without the approval of the Monroe County Board of Commissioners and the State of Tennessee Comptroller - Division of Local Finance.

NOW, THEREFORE, Be It Resolved by the Monroe County Board of Commissioners that the Monroe County Director of Finance be authorized to enter into a multi-year lease agreement with Image Matters and the lease is not to extend over a period of more than sixty (60) months.

WHEREAS, Monroe County, Tennessee along with most of the counties in the state of Tennessee house in the Monroe County Jail convicted felons servicing local time as well as state inmates and Tennessee Department of Probation detainees awaiting revocation hearings, and,

WHEREAS, the Tennessee Department of Corrections currently reimburses Monroe County, Tennessee at a rate of \$37.00 per day, whereas the actual county cost as calculated by the Monroe County Finance Director is much more than this amount, and,

WHEREAS, in addition to having to having convicted felons serving local time, state inmates, Monroe County, Tennessee also houses in its jail detainees awaiting revocations hearings, and

WHEREAS, the Board of County Commissioners of Monroe County, Tennessee does hereby request that the Tennessee Department of Correction amend its current rate of reimbursement of \$37.00 per day to the actual Monroe County, Tennessee cost as calculated by the Monroe County Finance Director for housing convicted felons servicing local time, state inmates, and Tennessee Department of Probation detainees awaiting revocation hearings and,

WHEREAS, the Board of County Commissioners of Monroe County, Tennessee does also request that the Tennessee Department of Correction expand the amount of reimbursement to include any inmate classified as Tennessee Department of Corrections inmate, local sentenced felons, probation and parole detainees awaiting revocation and further that compensation for medical care costs including offsite and onsite physician care, x-rays, prescription medications and dental procedures, and

WHEREAS, the Board of County Commissioners of Monroe County, Tennessee does further request that a copy of this Resolution be sent to all counties in the state of Tennessee with a request that these counties take similar action and that they also request that such action be taken by the Tennessee Department of Corrections and that copies of this Resolution be sent to our Tennessee state Senator and Tennessee state Representative representing Monroe County, Tennessee.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Monroe County, Tennessee, meeting in regular session on this 4<sup>th</sup> day of February, 2014, that:

- The Board of County Commissioners of Monroe County, Tennessee does hereby request that the Tennessee Department of Correction amend its current rate of reimbursement of \$37.00 per day to the actual Monroe County, Tennessee cost as calculated by the Monroe County Finance Director for housing convicted felons servicing local time, state inmates and Tennessee Department of Probation detainees awaiting revocation hearings.

# TO CONFIRM ELECTORAL DISTRICTS APPLICABLE TO THE OFFICE OF CONSTABLE FOR MONROE COUNTY, TENNESSEE FOR 2014 ELECTION CYCLE

WHEREAS, pursuant to T.C.A. § 8-10-101 et seq., Monroe County, Tennessee has earlier instituted the office of Constable as permitted by Tennessee statute; and

WHEREAS, Monroe County, Tennessee has specifically provided for the office of Constable to be elected for each of three (3) electoral districts, the lines for which were previously identical to the legislative district lines for the Monroe County Commission; and

WHEREAS, Monroe County, Tennessee, by Resolution 1107-1, enacted on November 7, 2011, adopted its most recent redistricting plan for Monroe County as required pursuant to Tennessee statute; and

WHEREAS, Resolution 1107-1 of the Monroe County Commission addressed only the creation of an additional legislative district for Monroe County, Tennessee, limited to the Monroe County Commission; and

WHEREAS, Monroe County, Tennessee wishes to hereby confirm that the electoral district lines for the office of Constable during the 2014 election cycle shall be and remain identical to the electoral district lines applicable to membership on the Monroe County Board of Education.

NOW, THEREFORE, BE IT RESOLVED, upon the passage of this Resolution, that there shall continue to be the office of Constable in Monroe County, Tennessee, to be elected from each of the three (3) electoral districts identically corresponding to the electoral districts applicable to the Monroe County Board of Education for the 2014 election cycle and each such Constable shall be elected to hold a four-year term of office.
