WHEREAS, on April 4, 2011, the City of Sweetwater passed ordinance No. 861; an ordinance to levy an additional sales & use tax; and

WHEREAS, this ordinance was placed on the City of Sweetwater ballot for the election to be held on June 9, 2011; and

WHEREAS, if this ordinance passes the local sales taxes in the City of Sweetwater will increase from 2.25% to 2.75%; and

NOW, THEREFORE, BE IT RESOLVED, that the County Commission declines to pursue a sales tax increase in Monroe County if said ordinance is passed by the citizens of Sweetwater.

BE IT FURTHER RESOLVED, if said ordinance fails to pass by vote of the citizens of Sweetwater, this sales tax option is left open for the County Commission to consider.

WHEREFORE, this Resolution shall take effect upon adoption.

524-10 POTENTIAL RECEIPT OF AMERICAN LEGION PROPERTY IN SWEETWATER, TN WITH A CONDITION OF SAID GIFT-APPROVED

American Legion Post 106 desires to give a lot & building by warranty deed to the county at no cost to the county. Joe Tolson and Ben Jernigan expressed that this property be used for emergency training, disaster response training and for the provision of emergency services from that location. They have agreed to put that in the deed, but they have asked that this provision not be a condition for conveyance of the property. A recommended period of five (5) years is stipulated to use the property for that purpose.

A request was made by the Monroe County Dental Department to declare 2 radiograph units as salvage material. The SS White Intra Oral X-Ray unit, control panel S/N M11351, and the GE Panoramic X-Ray unit, control panel s/n 183328 have been in storage since the dental clinic moved from the JP Kennedy building in 2006, the units did not work when they were removed. We have been paying a Tennessee Registration of \$65.00 per unit per year for a total of \$650.00. We want these units declared salvage so they can properly be dismantled and disposed of so we no longer have to pay this fee.
